Bureau of Indian Affairs' (BIA) Native Language Revitalization:

Technical support and facilitation of tribal engagement activities with American Indian tribes, Native Hawaiian communities, Native language scholars, language revitalization advocacy groups, and federal leadership to be used in developing a 10-year National Language Revitalization Plan



BIA's Renewable Energy Accelerated Deployment Initiative (READI) for Indian Country:

Facilitation for tribal consultations, technical work group facilitation, communications and outreach, meeting and event planning, literature review, and reporting



Bureau of Safety and Environmental Enforcement, Bureau of Ocean Energy Management (BOEM):

Subject matter expertise and meeting and logistical support for BOEM tribal consultations



Michigan State Native American Boarding School Study:

Conduct a preliminary assessment of the Native American boarding school history in the state, coupled with an examination of the boarding school system's implementation, conditions, experiences, and operations through quantitative and qualitative data collection and analysis



Affiliated Tribes of Northwest Indians (ATNI):

Facilitation of strategic planning with ATNI leadership, along with surveying constituents, to identify the vision, major strategic pillars, actions, and priorities for the organization over the next 5 years



Coquille Indian Tribe:

Collaborative planning and implementation of a community-wide visioning process for developing 15-year "Ko-Kwel Nations 2039 Aspirations" plan that involves a landscape analysis, community survey, community meetings, and reporting.

Planning, facilitation, engagement, and evaluation services for the Fund's college capacity enhancement and sustainability project with TCUs
